Our February event is a luncheon at the Carlisle Country Club. Our speaker is **Lt Col Jocelyn J. Schermerhorn, USAF, USAWC Class of 2015**. She will speak on her experiences in Air Force Special Operations assignments with an emphasis on some novel aspects associated with being a female officer in those environments. Additionally, she'll provide her perspective on how we should lead future generations with respect to integrating females into non-traditional roles. Lt Col Schermerhorn is a master navigator with over 3,500 flight hours, has participated in a number of worldwide contingency operations and is a veteran of Operations ALLIED FORCE, ENDURING FREEDOM and IRAQI FREEDOM. Her presentation will be followed with a few short remarks by **COL Bert Lennon, USA (Ret)**, about the proposed Home Rule Charter for the Borough of Carlisle that will be on the ballot during the Primary Elections in May. Not only is Bert a member of our Board of Directors and Editor of our Chapter Newsletter, but he was also elected by local voters in 2013 to serve as one of nine commissioners on the Carlisle Borough Government Study Commission.

LEGISLATIVE AFFAIRS

A good catch phrase to characterize upcoming 2015 legislative activities at the federal level would be: "New Year, New SecDef, New Congress -- Old Problems". Secretary of Defense nominee Ashton Carter awaits confirmation and the congressional leadership positions will be shuffled due to the recent mid-term elections. The new 114th Congress is poised to tackle several serious issues in 2015 that include the highly anticipated report from the Military Compensation and Retirement Modernization Commission, the looming return of sequestration, and increased calls for further defense spending reductions. All of these could have serious impacts on the pay and benefits of our membership. An excellent way to stay on top of all of these issues is to go to MOAA national's web site at www.moaa.org and subscribe to their weekly "Legislative Updates" email service. Also, I invite you to consider either mailing in the postcards that MOAA sometimes includes with the monthly Military Officer magazine or the proposed "Take Action" email alerts that address pending legislation that may impact the membership.

On the Commonwealth legislative front, 2014 ended on somewhat of a good note when veterans groups and AARP were successful in applying enough pressure to cause the Senate to shelve a proposed Pay Day Lending bill. This was Senate Bill 975 which would have legalized 300% interest, two week pay day loans. But, don't assume that this issue won't resurface this year as the bill's proponents are in leadership positions and may make another attempt to move the bill forward. The new Governor Elect, Tom Wolf, is opposed to the Pay Day Lending bill and hopefully he will exercise his veto if it gets through the legislature. So far, 2014 has only seen two new bills concerning military or veterans issues being introduced to the legislature's Veterans Affairs and Emergency Preparedness committee.

On Jan 14th, Senate Bill 56 which establishes a National Guard youth challenge program was introduced to the committee. The youth challenge program shall include at least a 22-week residential program and a 12-month post-residential mentoring period. The program seeks to improve the life skills and employment potential of youths who are 16 through 18 years of age by providing structured military-based training and supervised work experience, together with the program's core components of assisting participants with earning a high school diploma or its equivalent, leadership development, promoting fellowship and community service, developing life-coping skills and job skills and improving physical fitness and health and hygiene.

Senator Lisa Baker introduced Senate Bill 285 to the committee. This bill would authorize an "Honoring Our Veterans" license plate for motorcycles. This bill is similar to the bill that has already passed authorizing an "Honoring Our Veterans" license plate for passenger cars or trucks for \$35. \$15 of that \$35 is then donated to the Veterans Trust Fund. Veterans can obtain the plate for only \$20. Money in the Trust Fund is dedicated to helping needy veterans with food, utilities, mortgage or rent payments, health care and other necessities of life.
