## PA LEGISLATIVE UPDATE

#### Pay Day Lending

Recent intel from the capitol reveals that some legislators will try again to move the pay day lending bill, SB 975 r another bill. No action has been taken yet but we are planning to return to the capitol shortly to lobby the senators again to ensure they do not have enough votes to move it. On the last visit to the capitol October 24<sup>th</sup> team MOAA distributed materials to House Representatives on the Veterans Affairs Committee and House members that veterans.

The PA War Veterans Council sent a letter opposing any change of the state usury laws to the governor and leadership of the House and senate. The War Council received two letters in reply stating they were opposed to pay day lending. Rep. Katherine Watson, 144<sup>th</sup> District and Senator Rob Teplitz, 15<sup>th</sup> District.

## PA LEGISLATIVE UPDATE

## Veteran Legislation

Governor Corbett is holding a press conference in State College on Veterans Day at the 112<sup>th</sup> Air Operations Squadron, PA Air National Guard. He will be highlighting enacted veterans legislation and as well as legislation that remains in focus in the fall agenda.

Some of the legislation that could be included is:

**House Bill 107/Heffley** - Considering military education and training to satisfy licensing or certification requirements. Passed the House and in the Senate Appropriations Committee.

**Senate Bill 923/ Baker** – Extending and expanding the Military Family Relief Assistance program beyond January 2014. The program gives grants up to \$3,500 to needy PA active duty service members and their families. Referred to the House Appropriations Committee.

**Senate Bill I 102/Scarnati** - Reduced hunting license and Fishing licenses for disabled veterans. Passed the Senate, in the House Game and Fisheries committee.

**SB 1090/ Baker –** Extending Free hunting and fishing to disabled veterans paid at the 100 percent disabled rate. Passed the Senate, in the House Game and Fisheries Committee.

**Senate Bill 1004 / Baker** - Developing Opportunities in Veterans Education. Requires institutions of higher education to designate a single point of contact for Veterans where they can receive academic and financial assistance. Sill in the Education Committee since May 2013.

House Bill 472/ Barrar – Military Residency for Colleges provides an exception to residency requirements for in-state tuition to the Commonwealth's colleges and universities. It will also require that the sponsor rate for each community college be extended to the non-resident Veterans, their spouse and dependent children. Passed the House and is in the Senate Education Committee

**House Bill 43/ Harper** – "Give an Hour" to our Veterans – legislation would change current language to allow psychiatrists, psychologists and counselors the ability to obtain a volunteer license so that they may provide free mental health services via "Give an Hour". Passed the House, is in the Senate Consumer Protections and Professional Licensure Committee.

**House Bill 1205** – Veterans Lottery Ticket. Passed Veterans Affairs Committee. Bill is tabled at present. Governor is against it.

# Newport News, VA: New Class of Aircraft Carrier

As the Navy prepares for the Nov. 9 christening of the USS Gerald R. Ford aircraft carrier, the service is getting ready for 27-months of rigorous, integrated testing of the ship's new systems and technologies. As the first in a new class of higher-tech aircraft carriers, the USS Ford represents an ambitious Navy effort to integrate a suite of new technologies onto a single platform.

The innovations built into the first ever Ford-class carrier include a larger flight deck designed to increase the sortie rate as well as more powerful nuclear reactor cores, advanced arresting gear, dual-band radar, computer automation, turbine generators and an Electro-magnetic Aircraft Launching System, or EMALS.. The new ship is slated for commissioning in 2016, following the test period.

Military.com attended a media round table with Rear Adm. Tom Moore, the program executive officer for aicraft carriers. Check out the full story here about the ramp up for the USS Gerald R. Ford.

The concept with the Ford-class carriers, which will serve for a life-span of 50 years each, is to methodically replace the existing Nimitz-class carriers which were introduced in the 1970s, Navy officials said. While nearly complete, construction of the Ford has drawn criticisms from lawmakers and congressional watchdog groups for its escalating costs; at \$12.9 billion, the Ford is more than \$2 billion over budget.

The Navy says it is working vigorously to contain and reduce costs, adding that some of cost growth was due to what they called "first-in-class" costs, meaning non-recurring engineering and development dollars which will inform the entire class of carriers. The Navy is optimistic it can control cost growth on the second Ford-class carrier, the USS Kennedy, now also under construction.

The USS Ford's larger flight deck is intended to provide the Navy with an improved ability to project and sustain power by allowing for more flight missions. In fact, the new carrier will be able to generate 33-percent more sorties than Nimitz-class carriers can. That translates into 160 sorties per day, officials said. Navy leaders have also indicated that the USS Ford's flight deck and electronic systems were designed to accommodate unmanned systems as well, something which appears likely to factor prominently in the future.
