Our members made news

Ryan Aument, state senator, wrote an article for *LNP* on the state budget impasse. He noted that "Gov. Wolf---within minutes of receiving the (Republican-led) budget---vetoed the entire General Appropriations Act. That had not happened in over 45 years." Ryan also noted that the governor had "proposed a budget that sought to increase spending by \$4.7 billion.

Gene Moore was featured in The Scribbler's column in LNP. With an eye for the unusual, The Scribbler picked out an article Gene had written for The Journal of the Lancaster County Historical Society. In it, Gene defines the powwow as a practice of the Pennsylvania Germans designed to cure or relieve ailments in humans or animals and to ward off other kinds of evils. He tells, for example, of the powwow as practiced when one is intent on protecting one's home and possessions from fire. That eyebrow-raising powwow itself may seem a bit unsettling for some. Let's just say it starts with doing something highly uncomfortable to the stomach of a black chicken. But does it work? Gene is reported as not sure, but he will not dismiss out of hand a centuries-old practice that sometimes makes "you and your cow feel better, even if only psychologically."

Joe Pitts, U.S. Rep., was reported in *LNP* to be unhappy with the Supreme Court's decision allowing same sex couples to marry anywhere in the United States. He was quoted as saying, "Today's ruling will lead to grave infringements of religious freedom across the United States."

LNP reported that Joe was to be a speaker at the "Rally to Support Israel," at Clipper Stadium.

LNP later reported this comment he made to the rally about the agreement with Iran: "This agreement will be devastating to our security and the security of Israel."

He wrote an article for *LNP* in which he said, "In the past 30 years, life expectancy in the United States has increased by five years, and almost half of that increase took place just in the last decade." He also said, "Right now, there are nearly 7,000 known rare diseases afflicting nearly 30 million Americans. Of these diseases, only about 500 have cures. Government must not stand in medicine's way."

He wrote an article for *LNP* on Planned Parenthood and the recently revealed videos on sale of body parts, asking the question, "How many more videotapes must be released before people accept the humanity of the unborn child?"

Paul Ripple wrote *LNP*, asking the question, "Should the parents of a girl in high school help pay for the football program?" He noted that, "In Sweden and some other European countries, the public school is 100 percent academic. After school, the student goes to an athletic club and pays a fee."

Craig Stedman, District Attorney, was quoted in *LNP* on why he decided not to release the names of the officers who were involved in the fatal shooting of a fugitive. He said, "I've received information on a number of credible threats to the police officers from a number of different sources. I think in general the public has a right to know…but I do believe the risk to the police officers and those close to them are serious and real in his particular case."

LNP reported Craig's quote on whether we report undocumented immigrants to ICE. He said, "Generally, if we contact ICE, it's to see if it's a person they have an interest in, beyond merely being undocumented. He added, "In most cases, we would know in advance if ICE is requesting detention, and for what reason."

Bob Wilcox wrote an article for the August issue of *Senior News* with the headline, "A Salute to Our Veterans of the Final Battles of WWII.: Although the salute was to all veterans of WWII, the article highlighted the combat experiences of five Lancaster County veterans, including our members Todd Reboul, Dick Scott, and Eston White.

He also wrote an article for the fall issue of *b* magazine with the headline "A tribute to those who served in World War II." It told of the major battles of that war, the ecstatic joy when that war was won, and the dire fate of those who had started it.

He was one of 32 people whose brief recollections of V-J Day were carried in *Senior*

News under the heading "Remembering the day World War II ended."

An easy way to get your DD 214 form

The DD 214 Separation Form that records a veteran's separation from the military is one of the most important documents a vet needs, yet many of us over the years, have misplaced ours.

If you need one, it's possible to replace it on the Internet. But for some of us, that's not easy. By all means the easiest way to get a copy is through the Lancaster office of our U.S. Representative (and fellow MOAA member of our chapter) Joe Pitts.

Just call his office at 393-0667 and explain that you need a copy of your DD 214. They will send you a form to be completed, signed, and returned to them. They will then contact the National Personnel Records Center, obtain the needed DD 214, and mail it to you. It's just one more way in which Joe Pitts, himself a Vietnam veteran of 116 B-52 missions, is happy to serve vets like us.

An anecdote from the military days of one of our members, past or present

It happened on a very dark night off the coast of Nova Scotia. The diving officer was LT James Abert, a native of Manheim Township. He was a Navy reservist, as were his two lookouts . When the captain ordered the submarine to submerge, Jim shouted, "Clear the bridge" and sounded the diving alarm. Because of the configuration of the superstructure (called the "sail"), he heard, but did not actually see, the lookouts go down the ladder to safety inside the sub.

He says, "Then I saw moving shadows over by the port side light which was sill glowing red. I jumped up and grabbed the lost lookout by the leg and basically stuffed him down the ladder. The quartermaster, inside the sub, counts the number of people coming down, and when he would have found we were short, he would have stopped the dive. But that young man lost in the sail would have had to hold his breath for some time if he had remained where he was during the dive."

Another special memory for Jim was the time his diesel sub was on patrol on the channel between Honshu and Hokkaido, Japan. They were ordered to the Sea of Japan, where they would be part of an exercise with Japanese Maritime Defense Force's aircraft. He explains, "One of their planes would fly over us, and we would then submerge. I was on the bridge when the plane flew over, and we were to submerge. So I did uga, uga (the sound alarm) and called, 'Dive, Dive' on the broadcast system. Just like in the movies. But the sub did not submerge. I flooded every tank I could to make us heavier, and slowly, we did get down. The problem was that the salinity of the Sea of Japan was much higher than the Pacific Ocean. We had no time to do a trim dive before getting on station, so I had literally to drive that boat into that salty sea."

It's been said that life aboard subs was great. Was it? "Well, the quarters were very crowded," he says. "And the air was bad, since lots of people smoked. But the food was great. I remember one time being docked at Subic Bay, in the Philippines next to a British sub. They'd have us over for cocktails, since they had the liquor, and we'd invite them over for dinner, because we had the steaks."

We honor the memory of...

Gerald "Jerry" E. McOmber, who died July 7. He was a graduate of Miami University of Ohio, where he received his Naval Commission in 1957. He then earned the unusual distinction of having qualified in the Navy as a pilot of single and multi-engine aircraft as well as lighter-thanair craft. He was one of the last Navy blimp pilots flying at NAS Lakehurst, NJ. He retired from the Navy Reserve in 1977 as a Commander. Over the years, Jerry served our MOAA chapter with dedication, He was president in 1997 and served on our board for four years. He and his wife Joann were regular attendees at our chapter meetings throughout the years and were strong supporters of all our chapter's activities. He is survived by his wife

Joann, a daughter, a son, and 2 grandchildren. Jerry had been a member of our chapter since August 1990.
