PRESIDENT’S CORNER

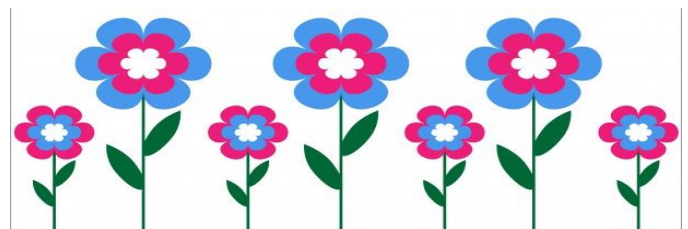

Services Turn Focus to Warfighters as Defense Health Agency (DHA) Takes Over Military Hospitals

The military health system provides medical care to more than 9.6 million beneficiaries, including 1.3 million active duty personnel. The military health system is in the middle of a major transformation, with DHA taking control of the medical facilities operated by the individual services.

By October 2019, roughly half of all military facilities will be under DHA management; the remaining facilities will consolidate under DHA by October 2021.

On April 3rd, the head of the DHA and the Services' Surgeons General outlined their approaches to realigning the military health system, including changes that will have civilians providing the majority of care to beneficiaries and a slimmed-down uniform staff focusing primarily on operational medicine.

The estimated number of uniformed medical billets to be eliminated is [between 15,000 and 17,000 billets](#); roughly 7,300 [Army](#) billets, 5,300 Air Force billets and 3,100 Navy billets. DHA, which manages the TRICARE program, is weighing options for replacing that care, including hiring civilians, using contract staff, entering into "military-civilian partnerships" or using existing [TRICARE](#) networks.

The Air Force has established Operational Medical Readiness Squadrons to treat only active-duty patients and Health Care Operations Squadrons to treat all other beneficiaries.

Letter from CDR (R) Bruce Apgar

Thanks to the generous support of individual CV-MOAA members, Chambersburg NJROTC was able to conduct a first-ever Basic Leadership Training resident camp at Ft Indiantown Gap in 2018. The program is co-sponsored by the Harrisburg NJROTC and the PA National Guard. Building on their initial success, they are planning to repeat the event and invite additional JROTC’s from South Central Pennsylvania.

The program will offer selected students a 4day/3night immersive leadership training experience. Many of the services and facilities are provided to us at no-cost by the PA National Guard. Remaining costs include meals, transportations and some instructional expenses. Many of the CASHS Cadets are below the poverty level and Commander Bruce Apgar (the Senior Naval Science Instructor) would like to find sponsors for these Cadets to cover the cost of attending.

With an expanded participation of 12-15 Cadets, the total cost for the event is projected to be about \$1500. The projected cost is \$100.00/Cadet.
