In the world of MOAA they are new developments:

- A new chapter dues collection system (at no cost to us) that will enable you to pay your chapter dues online. MOAA takes no commission. Dues are the lifeblood four chapter. The portal will be introduced in the next quarter.
- A new legislative tool to make it easier for you to contact your legislators and state your concern about the many issues affecting active, former, and retired service members and surviving spouses. With the April month of Advocacy in Action (AIA) approaching, I along with other members in this chapter and across the state will be visiting in person and virtually with our senators and representatives and advocating on behalf of our membership. I visited with Senator Casey's office two weeks ago, getting an early start on AIA.

And at Pittsburgh MOAA there is a *lot* of news. Last week I traveled to MOAA headquarters in Alexandria, VA and met with MOAA staff including Dana Atkins, the CEO and president of MOAA. **Please read all of this.** I will have more to say in April and in the coming weeks.

It quickly became clear that for Pittsburgh to continue as a viable chapter, a number of things must happen including:

- We must incorporate. A non-profit corporate structure provides advantages and a corporate shield for the membership and its officers.
- We must bring our dues collection into compliance with MOAA standards. Only 17 chapter members pay dues out of the 202 we currently have. That is unacceptable and we have been lax. Dues for many years have been \$10 (the cost of a drink at Chartiers); MOAA sets minimum chapter dues at \$12 - a dollar a month and they'll even collect them for us without taking a fee. Dues keep the chapter afloat, allowing us to do things like honor ROTC/JROTC cadets & midshipmen, support veterans, service dogs, and the like. Things we are supposed to be doing.
- We must adopt by-laws and standard operating procedures.
- We need to get into compliance with the current tax laws. That does not mean that we will have to pay taxes. We are non-profit but there is a

structure for that. It does mean that there are things that we have to do to get into the good graces of the IRS. The Navy League and other organizations serving military affiliated groups already do that. So must we.

- We must become insured against common liabilities. We are currently uninsured. That's like going out into the rain and not having an umbrella. This is not 1965 anymore; we live in a litigious society. The chapter must carry liability insurance to protect the chapter, the membership, and its dedicated volunteers. Guest Dick Buckley's fall at the Christmas party should have been an eyeopener. MOAA makes it easy with special chapter insurance through Mercer. The premiums are small, measured as a few dollars per chapter member per year. And by becoming insured, we open the door to being able to apply for community service grants from MOAA that will help pay for the things we should be doing in the community for veterans, service members, and young ROTC/JROTC students. That's money we have passed up for many many years. Without insurance we are currently ineligible to apply for these grants. Insurance guotes are pending.
- We are culling our membership roster. We have brought in a number of new members of varying age, several of who have already stepped up to take roles helping the chapter to function. We claim a size of 202 current members but in truth we are a fraction of that size. Many people on our chapter roster have not been to a luncheon in years, have moved away, or otherwise have lost interest in what we do. We pay dues for them to the MOAA state council of chapters. Our insurance premiums will also go down if we are a smaller chapter. Why pay for members who aren't here?
- We are undertaking both community service efforts and social events in addition to our longstanding luncheon series. Younger people want to join an organization that does community outreach.
 MOAA expects that. Younger people, who will be sitting in these chairs when we are no longer able to do so, are necessary to continue this chapter as a vibrant organization. And we are growing because the new members see promise in what I propose. By adding a baseball game, a picnic, a Gateway Clipper intergenerational cruise, maybe a weekend bus road trip where you can take your children and grandchildren to the National Civil War Museum and the Army Heritage Center in the

Harrisburg/Carlisle area, possibly with time spent at Hershey Park. These are all ideas. We want to offer family-friendly activities for chapter members of all ages.

I can't do this all by myself. I need your help. We need your help. Some of our chapter officers have been stepping up for decades. We need to develop a group of previously-uninvolved volunteers and younger members to take over and lead or this chapter will fold, as others have in MOAA World. We all have to decide what's important in our lives.

Although we have been hard at work, we haven't been able to meet our ambitious timeline of having April, 2022 as our primary business meeting to vote on the path forward. We need to start up the electronic dues program; it may be in place before the April luncheon. We need to do that so we know who is eligible to vote. We need to circulate the proposed bylaws for your consideration prior to a vote of dues paying members. We need to take a vote on incorporating and so on. If you want a say in how the chapter operates it is only reasonable that you pay your dues first.

Pittsburgh VA Mandating COVID Vaccine for All Staff

There is an issue brought to our attention that the VA Hospital in Pittsburgh, not Philadelphia and not Washington higher-ups. The local VA sent a memo to their employees that if you are not fully vaccinated against COVID you are subject to dismissal. This could affect upward of 25% of VA hospital staff, and negatively affect the care the VA is able to give to local veterans.

Regardless of your view of the vaccine, the way Pittsburgh VA has chosen to go about solving the problem seems only to create other issues. I encourage you to contact your congressman and Senators Casey & Toomey to request their help on getting the VA in Pittsburgh to find another way to solve the vaccination problem that will not adversely impact patient treatment.
